The Prostate Net-Draft Electronic Survey (ENGLISH)

Introductory screen with Prostate Net logo plus respondent clicks (to continue in getting routed to questionnaire in appropriate language)

"Click here to proceed in English."

In Spanish "Click here to proceed in Spanish"

For the next screen, Virgil has drafted an introductory message stating the purpose of the survey. This message will appear after the respondent selects the language to take the survey (either English or Spanish, as appropriate). This message will be submitted to the IRB.

Special Instructions to Programmer:

- The only communication back to the server should be at the end of the survey or if necessary at pre-set junctures-NOT after each screen.
- Actual questionnaire should not have question numbers displayed. Similarly, do not include our comments that are addressed to the programmer.
- We have translated material into Spanish--see the attached related document. If you find the need to add additional, let us know and we will have our certified Spanish translator create the corresponding material in Spanish.
- The date, time (beginning & end), & PC's IP address should be automatically recorded by the computer.
 - Please maintain a file which links the PC's IP address to identifying information about the specific barbershop. (We shall be analyzing data by shop location, so this information is essential. In the event that the barbershop gets assigned a new IP address, the database should have a variable indicating multiplicity of assigned IP addresses, so that we are made aware that this is intentional.)
 - On the first questionnaire screen, record the exact date and time.
 - After each completed keystroke for check marks, text entry, or moving forward or back, record and update a separate variable (essentially a counter variable) with the time.
 - Record the complete date & time with each new screen.
 - Periodically, compare the above counter time with the real time clock on the computer. If this difference exceeds **X** seconds, flash a message on the screen alerting the user to continue or else the survey will be terminated. "Please continue with the survey or else it will end." If no response after **Y** seconds, terminate. We suggest that the response required be something like clicking on "continue with current questionnaire" with an option to instead switch to a new person with a new questionnaire. Do you have a recommendation for X & Y?
 - If a survey reaches the end or the person chooses to quit, record that time--update the counter variable to that time.
 - After recording the last time, calculate and save the time interval: end minus beginning.
- As per the meeting on May 4th, each new question will be on a new page (screen).
- Most choices are to be pick list using a mouse only wherever possible. Although you'll see letters before the answer choices below, the screen presented to the respondent, should merely have boxes that can be checked by a mouse click. As those letters are extraneous information

to the respondent, the letters should not appear--this approach should be an underlying guiding principle in screen development, to keep things as simple as possible in appearance.

- Allow only one box to be checked unless otherwise specified by us (e.g., where we tell respondent: "Check all that apply.")
- For those questions where only one response may be checked - if one clicks a different response, the prior response should automatically become unchecked.
- Some questions will need to have fill-ins.
- Insofar as possible, dynamically display questions and/or choices based upon the responses given so far.
- Respondents are not required to answer a question. However, only "complete" questionnaires are to earn credit for a free haircut (see below). The option must be provided to permit a question to be skipped, but there needs to be a pop-up alerting the respondent that they will not earn a certificate. In other words, questionnaires with missing responses are acceptable. Thus, provide the ability to click on "Next" in order to proceed to subsequent questions without having answered all questions.
- All questions MUST be answered in order for a certificate to print. If a question is unanswered, let the respondent know that in order to get a certificate the question needs to be completed. "To get a certificate for a free haircut, you have to answer the question on this screen. Click here to answer this question. If you wish to skip this question, click here." If respondent has clicked on the option to go forward to the next screen-check whether or not there is at least 1 response to the question on that screen. SO---please alert and allow them to [but NOT require them to] complete the skipped items before proceeding.
- For those screens that only contain a question requiring a single answer, program should automatically jump to the next screen when all the questions have been answered.
- Each screen should have an option to return to previous screens to allow the respondent to re-read questions and/or change answers.
- For those screens where there is a question that allows for multiple answers or that contains a text box, the respondent should have to click "Next" in order to proceed. For a response where there is a text box, please check that a response has been entered in the text box. If not the user should be alerted to complete the text box before proceeding. If the user has clicked on the "next" box, similarly, check if the text box has been completed and issue an alert if it not has not been completed.
- Question asking, " At about what age did you FIRST get a PSA test?" should contain a text box with two spaces where an age can be entered. Check that the response is greater than 18 years; if value is less than 18 years, alert the respondent (since PSAs are not done on kids).
- At the termination of the questionnaire, check which questions were skipped. Design the system to alert & re-present skipped questions to allow the respondent another chance to complete.
- When a certificate is printed, use the model designed by Mr. Simons. Include on the certificate a number, which should be sequential plus the day of week, date, and exact time of completion, and the IP address of the PC. Barbers will be provided with a stamp with the shop name, address, and phone number. Each certificate will contain a space for the respondent to write in their name and the barber's name, plus a place for the barber to stamp with the above information.
- For the questionnaires completed in Spanish, the certificates should have BOTH English and Spanish wording on them (so the respondent and his barber understand).
- At the termination of a survey, whether completed or not, create a separate log file, which records the above information (if a certificate was generated) plus the calculated elapsed time. This file should be periodically transmitted back to The Prostate Net. This log file will help us

with administration & monitoring the on-going activities at a glance, and will serve as a back-up summary to the actual surveys. The log should of course should include the IP address.

- On each survey that was begun: a record of the times, Wired barbershop IP address and all responses should be created and this file uploaded back to the Prostate Net. Provision needs to be made for the possibility that the Internet connection is transiently lost, so that this data is retained and sent to the Prostate Net when a connection is available.
- In the event the printer is not turned on, has no paper, is out of ink, or malfunctions, appropriate contingencies for handling need to be implemented. If something is re-printed, it should be labeled as "copy" or "duplicate" with retention of the same certificate number and date/time information. This will help diminish the possibility of inadvertent or deliberate duplication. Since the certificate is now going to be printed on a black & white laser, Photocopying is a potential concern; this will be resolved by the use of colored, pre-inked stamps applied to the certificate by the barber. Provision for the barber to print a certificate in case of malfunction needs to be made.
- The free haircut certificates--should have a 1-month expiration date and is not transferable. "This certificate expires in one month and only you can use it." Add a sub-line that says "Expires 30 days from date printed on certificate." (Virgil notes that most Black men do return within 1 month for another cut or could even use it that day.) The Prostate Net will break linkage after receipt & recording of returned certificates to the Prostate Net. The certificate number and date information would be cut off to accomplish irrevocable de-linking. The top portion with personal data will be periodically shredded.

The survey then begins on the next screen with skip patterns and termination points as indicated.

If something is re-printed, it should be labeled as "copy" or "duplicate" with retention of the same certificate number and date/time information. This will help diminish the possibility of inadvertent or deliberate duplication. Since the certificate is now going to be printed on a black & white laser, photocopying is a potential concern; this will be resolved by the use of colored, pre-inked stamps applied to the certificate by the barber.
- The free haircut certificates--should have a 1-month expiration date and is not transferable. "Este certificado expira en un mes y sólo usted puede usarlo." Add a sub-line that says " Expira 30 días después de la fecha imprimida en el certificado." (Virgil notes that most Black men do return within 1 month for another cut or could even use it that day.) The Prostate Net will break linkage after receipt & recording of returned certificates to the Prostate Net. The certificate number and date information would be cut off to accomplish irrevocable de-linking. The top portion with personal data will be periodically shredded.

The survey then begins on the next screen with skip patterns and termination points as indicated.
